The undersigned does hereby attest (or affirm) to the fact that the cattle you have brought to the Texas Longhorn Coop to be processed are in fact

1. With my signature, I _____ do attest that this/these animal(s) were bred, born, raised, and processed in the USA, thus fulfilling the COOL requirements for TLC labeling.
2. The undersigned does attest (or affirm) that these Texas Longhorn cattle are registered by a legitimate Texas Longhorn Cattle Association and have surrendered registration papers which will be returned to respective association. If cattle are not registered, their sire and dam are registered with one of these Texas Longhorn Associations.
3. These cattle have been raised on an entirely free roaming pasture.
4. These cattle have NEVER been confined to a feed-lot.
5. These cattle have not been fed or injected with any hormones or steroids
6. These cattle have not been injected or fed any antibiotics in the last six months.
7. All cattle subject to test for all the above. Any failure will result in rejection of carcass to be marketed under TLC label and will return to owner. Hides and horns may be retained by TLC to be marketed and sold under the TLC membership guidelines if TLC determines the quality meets the market needs.
8. TLC is not liable or responsible for any USDA or FSIS fines imposed onto TLC in response to a member not following guidelines set forth by TLC or USDA and/or by misrepresenting their animal(s).

Cattle Owner is to understand that the Texas Longhorn Cooperative is following FSIS and USDA standards for it's membership labels and products. All animals are subject to inspection by USDA and T.L.C. Owner is responsible for inspection results.

Any Hides or Horns not kept by owner may be retained by TLC and sold by and for TLC.

The undersigned has read, understands and agrees to all above requirement and does hereby attest (or affirm) that cattle meet all requirements.
